Gastreatment Services (GtS) BV wins Dutch Entrepreneur Award

Mathieu de Bas, managing director and one of the founders of Gastreatment Services BV in the Netherlands, is the winner of the Dutch Entrepreneur Award region Center of The Netherlands. A trophy and certificate were presented on the new year reception of the Dutch Chamber of Commerce on the 5th of January 2009 in the Theatre of Gouda.

The Dutch Entrepreneur Award is initiated by the Dutch Chamber of Commerce to both show that good entrepreneurship is valued and stimulated.

Gastreatment Services (GtS) is an engineering firm active in the field of gas treatment systems. GtS develops and realizes cleaning systems for biogas, landfill gas and digester gas. These gasses originate when organic material is processed (for example at landfill sites and in waste water purification installations). Using gas treatment techniques on biogas like the Total Contaminant Removal (TCR) and Gastreatment Power Package (GPP®), GtS extends the application of methane containing gasses and is able to generate a substitute for natural gas (bio natural gas) and liquid CO₂. Over the past 5 years GtS developed to an international acknowledged company in the field of desulphurization, siloxane removal and the production of clean biogas and liquid CO₂. Both are considered valuable products in Dutch greenhouses and for the carbon dioxide in soft drinks. According to the judgement of the jury Gastreatment Services BV has won the Dutch Entrepreneur Award for the following reasons: it shows courage and faith in its own capability to start a new company in a relatively new world of sustainable energy, in which several and most of all big players are active. Vision, persuasiveness and good timing brought GtS where they are now".

On the 8th of May 2007 Gastreatment Services formed a partnership with Scandinavian Biogas Fuels (SBF) from Sweden. The new joint-venture is named Scandinavian GtS and is located and founded in Sweden. Both owners spear technology within biogas production and gas treatment. This will be combined into one commercial entity with great business potential on the international market. Scandinavian GtS.





The core business of SBF is to optimize the production of biogas from waste water plants, produce biogas from stillage in conjunction with ethanol production and design biogas plants based on other sources of biological material.

On the 6th of November 2008 Scandinavian GtS announced plans for Sweden's first Liquid BioGas (LBG) filling station in the city of Sundsvall. Sundsvall will be the first city in the world with the ability to fill vehicles with LBG, a second generation of sustainable fuels.
